We are pleased to inform you that your name has been provisionally short listed as per the merit list of the candidates prepared by the University for Admission in B.Ed. Programme for January, 2020 Session. In this regard this is to inform you that as per new guidelines of NCTE for BED Programme IGNOU Regional Centre Chandigarh has been made the Nodal Regional Centre where Counselling will be held as per the revised Cluster-wise Merit list for Chandigarh, Srinagar, Shimla and Jammu regions for Admission in B.Ed Programme – January, 2020 Session. The total number of seats is 55 only. There will be only one Study Centre for BED programme for all these regions where all the activities such as Counselling (Theory), Workshop and Assignments related activities will be held i.e. *PSC* – 06016P, Dev Samaj College of Education for Women, Sector 36-B, Chandigarh. If the seats remain vacant after counselling, only then the next opportunity will be given to the wait listed candidate(s). No extra time will be given for submission of Demand Draft of the requisite fee to candidates of Waiting List.

Therefore, you are advised to report in person and attend the counselling as per schedule along with the **Demand Draft of Rs.55,000/-** and **true copies of attested/self attested relevant documents** (that will be retained with your application Form) along with the **Original documents** for verification. **A register of attendance of all applicants coming for the counselling will be maintained** where their signatures and time of arrival for the counselling will be recorded prior to their counselling.

(If you do not present yourself at the Regional Centre on the date and time allotted to you as above, the offer will automatically stand cancelled and admission offer will be given to the other candidates in the waiting list.)

The details of all the documents to be produced at the time of Counselling are given below:

# 1. <u>Documents that are required to be submitted by the Applicants (Photocopies duly attested, to be verified against original):</u>

#### (i). To be submitted by All Applicants:

- 1). High School/Secondary/Senior Secondary Mark Sheet and Certificates.
- 2). Graduation or Post graduation Mark Sheets and Certificates.
- 3). Study Centre allotment letter from the concerned University, in case of Degree(s) acquired through Distance Mode of Learning from Central/State/Deemed to be University.
- 4). Mark Sheet and Certificate of NCTE Recognized Teacher Education Programme completed through Face to Face mode.
- 5). Regarding NCTE Qualification in teacher education programme acquired through face to face mode, the candidates should produce the authentication by the Certificate Issuing Authorities stating that "the certificate awarded to the candidate is the NCTE recognized and approved teacher education programme through face to face mode". In case of non-existence of the Certificate Issuing Authorities at present, a certificate may be obtained from NCTE recognizing that course as a teacher education programme through face to face mode. (A Certificate issued by the Institution, where the candidate has pursued his/her teacher education programme through face to face mode, stating that the Institution is recognized for offering the teacher education programme through face to face mode by NCTE, along with a copy of the recognition letter issued by NCTE to that institution. In case the recognition letter is not available, then a certificate issued by the Institution should contain the details of the letter number and date of issue of recognition/approval for offering the teacher education programme through face to face mode by the NCTE).

# Without NCTE Recognition Certificates, the candidature for admission to B.Ed. will not be considered.

- 6). Letter of appointment from current school stating date of appointment and the post held (Primary Teacher, Assistant Teacher, TGT/PGT; as the case may be) and Salary/Grade given on school letter head bearing School Recognition No. in Original + self-attested Photocopy.
- 7). Original Experience-cum-Employment Certificate of the current as well as previous schools (On proper letterhead of each school) to be submitted in Original, if experience is claimed. Each certificate should have proper address of the school and should be signed and stamped by the Headmaster/Principal of the school, if teaching experience is claimed (Format enclosed).
- 8). School recognition certificate duly attested by the Headmaster/Principal of the school.
- Original Certificate from the recognized Upper Primary/ Secondary/Higher/Senior Secondary Schools to provide facilities for Practical Work including Internship, as per the format attached to it along with CPA Proforma.
- 10). Original BED Entrance Examination Admit Card. (Hall Ticket)
- 11). Original Anti-ragging Affidavits in the prescribed formats duly Notorised and signed by Parents and Applicant separately, as given in the Prospectus.
- 12). A Demand Draft of **Rs. 55,000/**-in favour of Indira Gandhi National Open University (IGNOU) and payable at Chandigarh, towards the programme fee along with the acceptance form (enclosed). Please write your name, Enrolment No., address and contact no. on the backside of the Demand Draft.
- 13). Two Passport size Photographs.
- (ii). By Applicants claiming reserved seat:

- 14). Category (SC/ST) Certificate for claiming SC/ST Seat.
- 15). OBC-Non creamy Layer [OBC (NC)] Certificate along with Income Certificate for claiming OBC (Non-creamy Layer) Seat. The OBC (NC) Certificate, not older than 3 years, should be in the format as given in the Student Handbook and Prospectus of the B.Ed Programme. The Income Certificate should not be older than 06 months.
- 16). Certificate of Physically Handicapped for claiming PH Category seat, with a minimum of **40%** disability.
- 17). War-widow Certificate for claiming War Widow Seat.
- 18). Kashmiri Migrant Certificate for claiming KM Seat.
- 19). The benefit of reservation under **EWS** can be availed upon production of an Income and Asset Certificate issued by a Competent Authority. The Income and Asset Certificate issued by any one of the following authorities in the prescribed format as given in Annexure-I shall only be accepted as proof of canditates' claim as belonging to EWS:
- (i) District Magistrate/Additional District Magistrate/ Collector/ Deputy Commissioner/Additional' Deputy Commissioner/ 1st Class Stipendary Magistrate/ Sub-Divisional Magistrate/ Taluka Magistrate! Executive Magistrate/ Extra Assistant Commissioner.
- (ii) Chief Presidency Magistrate/Additional Chief Presidency Magistrate/ Presidency Magistrate
- (iii) Revenue Officer not below the rank of Tehsildar and
- (iv) Sub-Divisional Officer or the area where the candidate and/or his family normally resides.

### (iii). By the Applicants whose name is changed after High School (all documents listed below):

- 20). In case any change in the name (other than the one mentioned in his/her High School Certificate), then it is mandatory for the prospective learners to furnish legal evidence of having changed his/her name/surname while submitting the admission form, as given below:
  - a) An attested copy of the Affidavit filed before 1<sup>st</sup> Class Magistrate specifying the change in the name.
  - b) An attested copy of the Notification in a daily newspaper notifying the change of name.
  - c) Attested copy of the Gazette Notification reflecting the change of name/surname.
  - d) An attested copy of Marriage Certificate issued by Registrar (Marriages) or Marriage Card in case of women candidates for change in Surname.

In case, the documents submitted by the candidate are found to be false, the admission will be cancelled. Tie cases of same marks will be resolved as per the norms of the University.

#### 2. Certificate to provide facilities for Practical Work including Internship

#### (To be submitted by All Applicants)

The candidates are required to provide the certificate in original at the Counselling from a recognized Secondary/Senior Secondary Schools to provide the facilities for Practical Work including Internship, as per the **format attached** with this letter.

#### **IMPORTANT POINTS TO BE NOTED**

- 1). This offer of admission is provisional and is based on the merit list prepared by the University and documents in respect of qualification and other eligible criteria submitted by you. At any stage, if it is found that documents/information furnished by you are false, your admission shall stand cancelled forthwith. No fee refund will be admissible in the event of cancellation of admission.
- 2). No relaxation will be given if you fail to provide any document given in the checklist or if any document is not as per University norms.
- 3). Degree acquired from an OFF-CAPMUS/OFF-SHORE CAMPUS of Central/State/Deemed to be Universities offered through Distance Mode of learning will be accepted for higher studies in IGNOU, provided these have been obtained as per territorial jurisdiction of these Central/State/Deemed to be Universities prescribed by the University Grant Commission (UGC) from time to time.
